Call to order:

Public Comment:

Lisa Collette spoke as the Family Engagement Coordinator for the Kansas Deaf Blind project. The programs are vital and represent a little more than 1 million dollars in funding. Eight states have had their funding revoked because the words inclusion and transition were found. This fund services less than 1% of the children. Kansas did receive the deaf-blind funding. Services in jeopardy include braille typewriters. This impedes these children their right to a fair and equitable education. National Family of Deaf Blindness has released a statement. These states are now appealing. An article with more information is attached to these minutes. Oregon, Washington, Wisconsin, Connecticut, Maine, Massachusetts, New Hampshire, and Vermont are the states currently affected.

Local Program:

Elizabeth Caselman, Part C Coordinator spoke about serving families in their natural environment

She spoke about how a child she serves was traveling with her mother as a semi-truck driver so the child's services were supported in the truck, the child's natural environment. Services focused on safety and how to support a child's development when they spend a lot of time in a car seat. One issue was how to provide toys that can be easily retrieved if they fall. Elizabeth was also flexible with meeting times based on when the mom would be in town. Some other places they met included truck stops, restaurants, parks, Wal-Mart, the mall, and a local swimming pool. The provider

supported gross motor development in the mall and at swimming pool. The child is now in child care and the provider now provides services at the child care.





Kansas Interagency Coordinating Council on Early Childhood Developmental Services , Meeting Minutes Written by Stacy Clarke

<u>Keisha Cross from Ross Elementary in Topeka #501</u> Provide a brief description about the different early childhood program(s) at your School

At Ross Elementary, we are fortunate to have two strong early childhood programs. We offer a full-day preschool class, as well as two Preschool Intervention Program (PIP) teachers, each of whom leads a half-day class in the morning and afternoon. The PIP program is built around a peer model, which brings together typically developing peers and students receiving special education services. This provides all students with an opportunity to learn from one another in a supportive and inclusive environment. How do you include early childhood programming into the decision-making process for your k-6 (elementary setting) when it comes to curriculum, school improvement, PLCs, etc.

Our preschool staff are included in the same conversations as our K–5 teachers. They are part of PLCs, professional development, and school improvement planning. Their input is important because we want to ensure that what happens in preschool connects with what students will experience as they transition into kindergarten and beyond.

How does your preschool program differ from other preschool programs in your district? What does your school offer for early childhood students?

Ross is one of only a few schools in the district that offers both a full-day preschool class and the PIP model. That allows us to serve more students and meet a wider range of needs. Our programs focus not only on early academics but also on social-emotional skills, family partnerships, and preparing students for success in kindergarten.

Share a brief description of Ms. Cross and her contribution to your school?

Ms. Cross has made a lasting impact on our school. Families regularly tell me how grateful they are for the foundation she gives their children, and even former students often share the difference she made in their lives. She is also continuing her own learning, working toward another master's degree in special education. Parents often call to request her classroom because they know their child will be cared for and challenged. Preschool sets the tone for a child's entire school career, and we are lucky to have Ms. Cross, who is an educator who puts students first, builds strong relationships with families, and is a true advocate for children.
