Goal 3: Inclusion in Part C and Part B 619

Assist and advise KDHE and KSDE on early childhood natural environments and Least Restrictive Environments (LRE) for children 0-5.

There is work happening on this at KSDE and with a Part B 619 Coordinator, this will continue to happen.

Refocus on promotion of foundational inclusion/differentiation/behavior management trainings in <u>child care</u> settings to support improvement of access and success for children with special needs.



Goal 4: Promote the management and function of the SICC as it aligns and compliments the "All in for Kansas Kids" strategic plan.

- Improve the availability of reliable resources and information for parents in a centralized location.
- Increase the availability of mental health resources for providers and caregivers.
- Improve the recruitment and retention of the local workforce by collaborating with others.
- Identified goals that aligned with the strategic plan
- Due to HeadStart funding cuts, Diana had to step down from chair of the committee.
- Committee has been learning about higher education work to align and support the recruitment and education of early childhood providers.
- Learned about a new Technical Assistance (TA) opportunity for recruitment and training of early childhood providers in Kansas.

Kansas has the opportunity to receive national technical assistance to improve the training, recruitment and retention of early childhood providers and teachers.
